


1. Question #2. Do you see the role of the CAC as advising only your district supervisor (as opposed to advising the Board of Supervisors as a whole)?



5. Question #4. Does your CAC have a mission statement in your bylaws or posted on your agendas?



6. If YES, do you find it helpful in clarifying the role of your CAC?



Do you think it would be helpful for your CAC to adopt a mission statement? 72 responses




Among those who said their CAC did not have a mission statement, 58% (7) think it would be helpful to adopt one, while 33% (4) did not.










17. Question #7. Are you aware that the Planning and Building Department provides training for new CAC members regarding the Land Use Process?

18. Have you attended the training?






Among those who attended the training (21), 90% (19 respondents) found it useful while 10% (2 respondents) did not.

Would it be helpful to have other relevant County Departments attend to discuss their processes at a CAC training?






23. Do you think having a code of civility is or would be helpful? Please elaborate.




27. Question #11. Do you think it is valuable for the CAC to be entirely elected, entirely appointed, or a combination of both?




29. Question #13: Does your CAC post and send notice and an agenda for regular meetings?

30. Question #14: Does your CAC record and post meeting minutes?



31. Question #15: Other than taking general public comment, does your CAC have a practice of limiting discussion to items only on the agenda?


Question #15: Other than taking general public comment, does your CAC have a practice of limiting discussion to items only on the agenda?


32. Question #16: Does your CAC livestream or record your meetings?

Question #16: Does your CAC livestream or record your meetings? 73 responses




33. Question #17: Does your CAC allow the public to address the council?

34. Question #18: Does your CAC conduct only public votes, with no secret ballots?


Question #18: Does your CAC conduct only public votes, with no secret ballots? 73 responses
